

Terms of Conditions - R-M New Clearcoats Promotion 2016 “Win the DS3 by R-M “Brilliant Red”

ARTICLE 1 – Promoter and organizer

The promoter and organizer of the R-M New Clearcoat Promotion 2016 (hereinafter referred to as “promotion”) is BASF France S.A.S. with its headquarters at 49, avenue Georges Pompidou 92593 Levallois-Perret Cedex, France, entered in the Register of Companies of Nanterre, 542 069 158 RCS Nanterre (hereinafter referred to as “Promoter”).

The promotion is organised in 8 European Countries (Germany, Norway, Spain, Portugal, Poland, Sweden, Finland, Denmark) and is promoted via the official BASF dealer distribution of R-M Automotive Refinish Paints. The promotion is limited to the purchase of the new clearcoat range (RAPIDCLEAR, see Promotion Flyer) launched in 2015/2016 to the dealers. The Dealer is not allowed to participate in the draw. Only the bodyshop customer of the R-M dealer in the listed country can participate.

The promotion is communicated via the Direct-to-customers communications Flyer/ Mailing, the website rmpaint.com and Facebook page <https://www.facebook.com/rmpaint/>.

Participation in the promotion is exclusively in accordance with the terms and conditions given here and, as the case may be, with the additional terms and conditions given on the game page.

The Promoter reserves the right to postpone, modify, cancel or renew the game if circumstances require. In any case, its liability will not be engaged in that capacity. The R-M dealer is not allowed to change the rule or condition of the promotion.

ARTICLE 2 – Period

The promotion will take place in the countries listed above in the defined period from May 2, 2016 until June 30th 2016 with the reserved and official tickets distributed.

ARTICLE 3 – Terms and conditions of entry

Each automotive refinisher bodyshop purchasing 5L of the new clearcoats at the official R-M dealer in his country can participate at this promotion. The purchase is registered with the invoice and the customer gets a ticket for each 5L ordered.

The R-M dealer by country is not allowed to participate in the draw.

ARTICLE 4 – How to participate

For each 5 Liters bought of a new R-M clearcoat (GLOSSCLEAR, RAPIDCLEAR, EASYCLEAR, EVERCLEAR or EXTREMECLEAR), the customer gets one numbered ticket (1 number for each 5L bought). The customer can participate when he sends back to the dealer the ticket with the name of the bodyshop and address. He participates with the tickets in the draw to win the DS3 by R-M painted car.

To participate in the promotion R-M New Clearcoats 2016, the bodyshop should follow the following steps:

- 1- Visit your country website www.rmpaint.com and learn about the new clearcoats and promotion communicated in the listed countries participating.
- 2- Find and contact your distributor in your country (listed on www.rmpaint.com). The dealer participating in this promotion receive the tickets corresponding with one number with the country R-M address from the R-M promoter.
- 3- Each bodyshop who buys 5L gets a ticket with a unique number and participates in the lottery from his Dealer.
- 4- To participate in the promotion and draw to win the prize, the bodyshop has to send back until July 29, 2016 latest the ticket or tickets (one for each 5L bought) with the
 - a. name and address of the bodyshop
 - b. the address of the R-M distributor in his country.
- 5- The dealer needs to send the tickets to the R-M organization in the country.
- 6- The R-M organization in each country (listed on the ticket) list and send the tickets to the central R-M Communications Department in Clermont de l’Oise until September 7, 2016.

ARTICLE 5 – Selecting of the winner

All customers who have purchased 5 L of the new clearcoats in the defined time of promotion and send back the ticket with the correct name of the bodyshop and address will take part with this ticket in the final draw of this promotion.

The winners draw of the main prize of the DS3 By R-M will take place between September 7 and 29, 2016 in the International R-M Refinish Competence Center in Clermont de L'OISE, France.

ARTICLE 6 – Prize giving
